## STIPENDIARY STEWARDS INCIDENT REPORT

### Race 01 – RTC PONY WELFARE RAFFLE CUP 1000M – 1/2 bred Handicap

Level start – Mr. A.V.K D Silva was fined a sum of Rs. 5000/- for the groomer not wearing a bib in the paddock while leading his horse. Jockey of Sri Lankan Queen L.Ravikumar was fined Rs.2000 for using his reins on his mount and severely reprimanded.

### Race 02 – SPORTING TIMES CUP Class 5 Handicap 1400M.

Level Start – KRABI was withdrawn extremely fractious refused to be stalled. No. 6 WAITING FOR GLORY (S. Dasadaran) dropped his whip at 600 mts. he was further cautioned for coming wide into the straight and continued to do so till the winning post for no apparent reason,

### Race 03 – THE BLACKPOOL HOTEL CUP 1600M Class 2 Handicap

Horse No. 3 GAZAKI was slowly away and lost 5 lengths at the start.

### Race 04 – RTC MAGIC MILLION CUP Sweepstakes 1800M

Level Start – Horse No.01 – ALCAZABA (Aneel) came wide into the straight till the 300 mts. No.5 MEHERAN came wide into the straight till 300mts. Both jockeys were reprimanded for excessive use of the whip first infringement.

### OBJECTION 4th Race

Jockey Aneel the rider of ALCAZABA placed second by the Judge lodged an Objection against Jockey A. Imran Khan the rider of MEHERAN placed First by the Judge. The objection was filed on the grounds by Jockey Aneel rider of Alcazaba against Jockey Imran Khan rider of Meheran where Jockey Aneel stated that his mount Alcazaba was hit on the face by Jockey A. Imran Khan on top of the straight which costed him the race. The Stipendiary Stewards on receiving the Objection immediately asked the Senior Vet Dr. J. Thangaraj to examine the mare Alcazaba for any injuries on the face. He examined the Mare and declared that there were no evident or visible mark or marks on Alcazaba's face. The Stipendiary Stewards then interviewed both the jockeys namely Aneel and Imran Khan. After taking into account their respective submissions and viewing the Video Footage which was made available it was decided to overrule the objection. The decision to overrule the objection was unanimous.

### Race 05 – MINISTRY OF INTERNATIONAL TROPHY 1600M Class 3 Handicap Level Start

### Race 06 – SPORTING STAR CUP 1400M Class 4 Handicap

Level Start – No.1 – STORMONT was inconvenienced approaching 100mts by Horse No.7 CRIMSON QUEST (S. Suganthan) was reprimanded for not keeping a straight course. Horse No. 2 – LEGAL LEGACY jumped out awkwardly travelled wide for no apparent reason, jockey was reprimanded to keep a straight course. Horse No. 5 – VIGOROUS (S. Punithraj) travelled wide throughout the race till the winning post for no apparent reason, jockey reprimanded to keep a straight course. Colorato (L.Daylan) reported that his saddle slipped back approaching 200mts. Trainer of Colorato S.P.A.Raju was fined Lkrs.3000 for Faulty Saddling.

### Race 07 – RTC CHALLENGE TROPHY 1000M 3/4 bred Handicap

Horse No. 4 – SPIRITE (S. Pradeep) whipped around to the left dropped rider 1200mts ran riderless opposite side.
